Minutes of Meeting held on Tuesday 8th September via Video Conference Call at 8pm

249. Apologies for absence

Apologies were received and accepted from Cllr Spooner, Cllr Hewett and Cllr Walker.

250. Declarations of Pecuniary and Non-Pecuniary Interest

There were none.

251. Reports - County, Borough and Police

County Councillor Sarah Hohler reported that the KCC budget has had to be re-organised to save money. It was also reported that unaccompanied asylum seekers can no longer be taken into Kent as the limit has been reached. 589 young people under 18 had been taken into foster homes and 945 over 18 are leaving care which has put pressure on the authorities. Cllr Hohler reported that the Government is reviewing its position on asylum seekers and in the meantime they have been moved to other local authorities.

It was noted that the borough has the lowest level of flytipping in the county and this is the only borough without a household waste recycling centre. The plan for new site at Allington is that it will be open and running in one year.

Cllr Hohler reminded councillors to look out for the chairman of KCC, Graham Gibbons, who is walking round the county to raise money for the homeless charity Porchlight and will be walking through Trottiscliffe to West Malling as part of his route.

Cllr Hohler confirmed that changes will be made to the M20 diversions and more enforcement will be in place to improve conditions for local residents.

Cllr Hohler updated the council on this year's KCC Grants as they will be terminated as of 31st December due to the forthcoming elections, and the delays to Highways Improvement Plans were noted. It was confirmed that the new highway scheme in Woodgate Road was from s106 funds, not a HIP. Cllr Hohler may be able to give BPC a direct grant if possible. Cars and HGVs are taking shortcut along Stangate Road. A good place to locate signs 'not suitable for HGVs' had been found. It was suggested that a width restriction and the appropriate signage be implemented.

The Police report was circulated prior to the meeting. A burnt-out car and two burglaries had been noted.
