Cllr Hewett reported that Ryarsh had 7 responses to the RPC consultation and all were said to be in agreement with the proposals.

Birling PC members had reiterated the views however RPC disagree on these points.

It was noted that the email that was sent to RPC be sent formally to KCC to inform them of BPCs views.

An additional proposal was raised about installing a speed indicator sign on the road between the two villages.

It was noted that RPC have decided not to put the sign up on Old School Lane. KCC's advice was that a table top would not be acceptable to the bus company however they could put speed cushions at Bull Road. KCC will measure for this option and report back.

KCC were receptive to the idea of 40mph either side of the village, it was suggested that Whitehorse Road be included for extra signage.

The suggested areas for the speed limit changes would be to Birling Road – Bull Road and Snodland Road beyond Church to Snodland.

It was advised that when installing double yellow lines there must be a minimum of 10m in length and it was agreed that this information will need to be included in the proposal.

An additional box would be added to the BPC document for any other suggestions and an explanation that this is subject to the levels of funding required being available.

It was **RESOLVED** for Cllr Walker to request a meeting with the headmaster of Ryarsh School to explain the actions of Birling Parish Council.

The clerk will request from KCC the total available funds.
