## <u>Draft Minutes of Meeting held on Tuesday 10 September 2013 in Birling Village Hall at 8pm</u>

## 1 Apologies for Absence and Declarations of Interest

Cllrs Sarah Hohler, Ann Kemp, Colin Grimmett and David Hopper and PCSO Laura Bullen. Cllr Nevill was absent.

## 2 Reports

PCSO Bullen had emailed her report that there had been no reported crimes in Birling in July and August but there had been 3 incidents in Ryarsh. Cllr Westwood said that a metal gate had been reported stolen from the entrance to The Kennels below Church Field.

Cllr Balfour reported that TMBC had decided that some of the new home money paid to them by government would be passed on to the parishes to help offset reductions in the allocation for next year.

# 3 Approval and Signing of Minutes of Previous Month's Meeting

It was **RESOLVED** that the minutes of the meeting held on Tuesday 8 July 2013 be **APPROVED** and **SIGNED** by the Chair.

## 4 Matters arising and last month's circulation

#### (a) Traffic calming repairs

Still no update from Kent Highways.

## (b) Unsuitable for HGVs Sign

Highways had advised that, as no injuries/fatalities had occurred, a larger sign would not be installed.

#### (c) Church Wall

Repairs to the wall had been completed. The clerk had written to the PCC asking if vegetation on the wall by the road could be cutback.

#### (d) Steps to Church Field

The Footpath team at TMBC had advised the Clerk that to extend the handrail and add steps to the footpath reducing the width of the path would be detrimental and, therefore, no further work would be undertaken. Cost had not been a factor in this decision.

## (e) Vegetation clearance on public rights of way

Cllr Westwood had provided details of the 2 overgrown paths but it was too late for them to be included in the contractors 2<sup>nd</sup> cutting. Clerk waiting to hear whether the Footpath team would be able to clear them.

#### (f) Electricity Supply

A new quote had been received from EDF at a slightly reduced annual cost of £487 for the next 12 months, wef 1/10/2013, and it was **AGREED** that the quote be accepted.

# (g) Any other matters arising JPCTCG

The Clout Memorial Hall in West Malling would be the venue for future meetings. Cllr Westwood noted that in the minutes of June's meeting the possibility of JPCTCG amalgamating with KALC to bring their views to a wider audience had been discussed. The councillors thought that this would be beneficial and **AGREED** that if a vote was called for at the JPCTCG 19 September meeting our representatives (Cllrs Nudd and Grimmett) should vote in favour.

No other matters were raised under this heading.

#### 5 Parish Business for Decisions

# (a) Review of Standing Orders & Financial Regulations

Cllr Westwood and the Clerk had reviewed both documents and were of the opinion that no amendments to the Financial Regulations were necessary but that the Standing Orders 1(q) should be amended to show that the TMBC Code of Conduct under section 27(2) of the Localism Act 2011 had been adopted. It was **AGREED** that this be done and the Chair and Clerk signed the amended document.

## (b) Donations

Letters had been received from CAB and Victim Support. All donations were discussed and it was **AGREED** to make the same donations as in 2012-2013 ie

It was noted that overgrown vegetation along one half of the land in front of The Stables had been cut back but that the other side had not and the Clerk was asked to contact Ryarsh PC again.
