KALC Annual General Meeting 19/11/2022 (in person)
The county council budget deficit was noted and a parish support scheme will be launched to assist parishes that are struggling financially. Adult Social Care and Children's services will take priority as the statutory services. Parishes were recommended to seek qualified Highways advice when developments are being built as this will be considered in addition to any County Council planning application responses.

ii. JPCTCG – 23/11/2022

It was noted that the group has folded, and all transport issues will be dealt with by the KALC area meetings in the future. It was noted that the 58 and 70 buses are being removed in February 2023. KCC are receiving an increased grant for community buses and there is some government funding available. Parishes are looking to run their own bus service. This will be

further explored urgently, due to timescales for funding, at the forthcoming KALC meeting this week. Other items discussed were Kings Hill phase 3/Broadwater Farm. J5 slips, 20 is plenty.
