274. Apologies for absence

Apologies were received and accepted from Cllrs Hirst

275. Declarations of Pecuniary and Non-Pecuniary Interest

There were none.

276. Reports - County, Borough and Police

Cllr Hohler reported that school attendance is improving at 94%. The government have given Tonbridge and Malling Council and Kent Police £54,000 to share within the borough to spend on enforcing COVID rules. Cllr Hohler reported that the borough has the lowest rate of COVID infections.

Cllr Hohler advised that illegal immigrants remain an issue in Kent but it is hoped this will improve when the weather deteriorates.

Planning was discussed and it was noted that KCC has opposed the government white paper on planning with concerns about infrastructure. The proposals implied sharp increases in housing in Kent which KCC think are not logical.

It was noted that a HGV had been stuck on Snodland Road and the HGV company has agree to trace the driver and advise all of their drivers.

Signs are being installed at the beginning of White horse Lane to prevent this issue reoccurring.

Cllr Spooner joined the meeting at 20:16pm

Cllr Montague addressed the meeting and advised that there is a debate taking place at TMBC on how to spend the government COVID19 enforcement funding.

Cllr Montague reported that the waste collection continues to be an issue however personnel changes are imminent at Urbaser which should help. It was noted that the new manager in charge is a local resident which should help in understanding the issues.

Cllr Montague advised that the brown bin collection payment renewal will be extended by two months to residents that have paid as means of compensation.

Cllr Montague gave an update on the Kent Dog Walkers site and agreed to give a further update later on this week.
